

**CITY OF LA HABRA
NOTICE OF PUBLIC HEARING AND REVIEW
DRAFT ACTION PLAN SUBSTANTIAL AMENDMENT**

Notice is hereby given that the City of La Habra has prepared a Draft Substantial Amendment to the 2019 Community Development Block Grant COVID-19 (CDBG-CV) Action Plan to include new programs and modify existing programs. This amendment is conducted in accordance with guidance provided by the U.S. Department of Housing and Urban Development and the City of La Habra's Citizen Participation Plan. The City of La Habra plans on receiving an additional \$569,260 in CDBG-CV allocation (CDBG-CV3) to fund housing and community development programs to mitigate the impact of the COVID-19 pandemic on low- and moderate-income residents through a new strategic goal titled "COVID-19 Response."

Changes to the CDBG-CV Substantial Amendment are as follows:

- Create new program titled "Social Services Program for At-Risk Persons" to assist La Habra residents that have been impacted by COVID-19 budget of \$200,000
- Increase Rental Assistance program budget by \$255,408
- Increase Administration activity budget by \$113,852

In accordance with waiver authorization provided by the U.S. Department of Housing and Urban Development, the City will provide the amendments for review and comment for a 5-day comment period on the City's website prior to the public hearing.
