- Political Booths will be assigned in the Free Speech Zone
- Vendors may not pass out information in the crowd. City staff will make announcements to visit the general vendor booths.
- Vehicles are not permitted in the park. You may use the temporary parking in front of the park on Euclid St. to unload and load. When finished, you must park car in the museum , city hall, or community center lot.

IT IS THE INTENTION OF X\_\_\_\_\_ BY THIS INSTRUMENT, TO EXEMPT AND RELIEVE THE CITY OF LA HABRA AND THE RELATED PARTIES MENTIONED HEREIN, FROM ALL LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY THE NEGLIGENCE OF ANY PERSON OR ENTITY.
